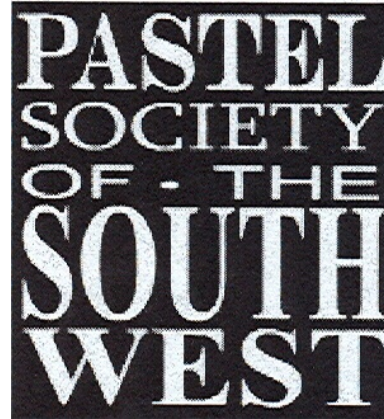

**JUROR KATHLEEN COOK**

PSSW is privileged to have Kathleen Cook as our juror and awards judge for our 2010 national juried exhibition. Kathleen is nationally known for her beautiful effects of light and color and her sensitive and accurate portrait and figure work. She also enjoys painting still life, landscape and animal subjects with the same enthusiasm and skill. Kathleen Cook is a signature member of PSA and has received many awards through out her career. Her work has been featured in various art publications and she has juried numerous shows.

Kathleen resides in Kerrville, TX and maintains a studio where she teaches in Ingram, TX. Kathleen's favorite art medium is Pastel. **"It's like painting with the stuff of butterfly wings!"**

**ELIGIBILITY**

- Open to members of the Pastel Society of the Southwest, work in pastel only.
- Entries must be original, unpublished and executed in the last three years.
- Student work produced under supervision is not eligible.
- Entries must not have been previously exhibited in a PSSW juried exhibition.
- Entries must be suitably framed under glass or Plexiglas and ready to hang with wire hangers. Saw tooth hangers are not acceptable.
- Framed work must not exceed 48" in height or width.
- All accepted work must remain at Artist's Showplace for the duration of the exhibit.
- The PSSW reserves the right to reject any work not meeting eligibility requirements, or deemed inappropriate to Artist's Showplace (including frontal nudes) even after painting has been accepted.

**AWARDS**

- Cash, gift certificates and merchandise in excess of \$4000, will be awarded.
- Best of Show will receive a \$1000 cash award.
- 1st and 2nd Place Awards of Excellence will receive cash awards.

## JURIED BY CD, 3 IMAGES ONLY

- Your CD must contain "Titles of entries."
- Images must be in jpg form and no larger than 2 mgs.
- CD's will not be returned.

## DELIVERY AND RETURN OF SELECTED ENTRIES

- Shipped entries must be received by the shipping agent between October 11th and 20th, 2010. The shipping agent is Craters and Freighters and shipping charges are \$45 for one painting, with \$10 charge for each additional painting. Shipping address and more information will be included in accepted works packet.
- Do not ship by bus.
- Hand delivered entries will be accepted Saturday, October 30, 2010 from 1 p.m. to 5 p.m.
- Shipped entries must be prepaid in reusable crates.
- Insure for your own protection.
- Shipping instructions, including handling fees and return shipping instructions will be sent upon notification of acceptance.
- Shipped entries will be packaged and returned no later than December 15, 2010.
- Pick up hand delivered entries November 27, 2010 from 1 p.m. to 5 p.m.

## LIMITATIONS OF LIABILITIES

Artwork and CDs will be handled with all possible care; however, neither the Pastel Society of the Southwest, Artist's Showplace, Craters and Freighters or any member of the PSSW will be responsible for any loss or damage. Glass is used at the artist's risk. Artists will be responsible for replacing broken glass. Entering this exhibition shall constitute an understanding and agreement on the part of the artist with the conditions stated. PSSW suggests artists carry separate insurance. Permission to reproduce artists work for publicity purposes is assumed with acceptance.
